# Annual Permit


## Permit

The owner must obtain permit from Garrett County Government for \$25. The permit must be affixed to the rear of the all-terrain vehicle or left fender of the snowmobile.

The permit will expire on December 31st of the year indicated on the decal.

## Insurance

All-Terrain Vehicle, and snowmobiles operators must have proof of valid liability insurance covering his/her vehicle.

# Purchase Permit

## Registration Checklist

- ✓ **Valid Drivers License or Exempt**  
See Maryland Transportation Article 16-102
- ✓ **Proof of Insurance**



## Operation Checklist

- ✓ **Properly placed sticker permit**
- ✓ **Helmet required\***
- ✓ **Utilize all safety equipment**
- ✓ **Maximum speed of 25 mph**
- ✓ **Far right side of roadway**
- ✓ **Garrett County maintained roadways only**
- ✓ **Headlights and tail lights**
- ✓ **Obey all laws of the roadway**

\* Unless the ATV or UTV is equipped with a factory R.O.P.S. (Roll Over Protection System), the operator or passenger of the ATV or UTV will not operate on any portion of the roadway unless the operators and passengers are wearing protective headgear that meets the standards established by the Administration as defined in TA 21-1306.

In such cases where the ATV or UTV is equipped with a factory R.O.P.S. (Roll Over Protection System), the operator and passengers will utilize the factory seat belts when operating the ATV or UTV on any portion of the roadway.



# Penalties

Any person who violates the provisions of this ordinance, or who owns or has control over an ATV or snowmobile and knowingly permits it to be used in violation of the provisions of this ordinance is guilty of a misdemeanor/municipal infraction.

## **First Violation**

\$100 fine

## **Second Violation**

\$250 fine *and* a 60 day suspension from using ATVs or snowmobiles on Garrett County maintained roadways

## **Third Violation**

\$500 fine *and* a lifetime suspension from using ATVs or snowmobiles on Garrett County maintained roadways



# Operation

ATVs and snowmobiles may be operated on Garrett County maintained roadways under the following conditions:

All-Terrain Vehicles, and snowmobiles must have at least an operating brake light and headlight when in operation on Garrett County Roadways.

All All-Terrain Vehicle and snowmobile operators on Garrett County Roadways must possess a valid driver's license or be expressly exempt from the licensing requirements of the Maryland Transportation Article 16-102.

Unless the ATV or UTV is equipped with a factory R.O.P.S. (Roll Over Protection System), the operator or passenger of the ATV or UTV will not operate on any portion of the roadway unless the operators and passengers are wearing protective headgear that meets the standards established by the Administration as defined in TA 21-1306.

In such cases where the ATV or UTV is equipped with a factory R.O.P.S. (Roll Over Protection System), the operator and passengers will utilize the factory seat belts when operating the ATV or UTV on any portion of the roadway

No passengers are permitted on single seat All-Terrain Vehicles and snowmobiles; passengers on all other All-Terrain Vehicles, and snowmobiles are limited to the number of manufactured installed passenger seats on the vehicle.

All responsible applicable for speed abiding limits by-25 Operators mph speed are limits put on even notice if their that vehicle they are is not equipped with an operable speedometer.

All-Terrain Vehicles and snowmobiles may be operated on Garrett County Roadway for a distance not to exceed five (5) miles.

All other motor laws of the State of Maryland shall apply.



# Roads

All-Terrain Vehicles (ATV's) as defined by (Maryland Transportation ARTICLE 11-103.3) and snowmobiles are hereby allowed on roads in the Garrett County Roadway Inventory ("Garrett County Roadways").

All-terrain vehicles and snowmobiles **MAY NOT operate on Municipal (Town) roads** unless the municipality has adopted appropriate legislation. Check with the local municipality before riding. ATV's and snowmobiles **MAY NOT operate on State Highways.**

All-Terrain Vehicles and snowmobiles must travel single file on the right-hand shoulder or the extreme right hand side of a road and left hand turns made be made from any part of the road if it is safe to do so under the prevailing conditions.
