# **ADMINISTRATIVE SESSION**

Garrett County Fire & Rescue Association – Jeremy Whitacre, representing the Garrett County Fire & Rescue Association (Association), made a request for the Board of County Commissioners to consider providing a property tax credit to volunteer fire and EMS personnel as authorized in House Bill 721. Mr. Whitacre stated that the Association believes this would be a recruit and retention tool to help keep current volunteers and attract new members.

House Bill 721 provides for up to a maximum of \$2,500 or the amount of the property tax. Currently the Association identified approximately 205 volunteers who may be eligible.

The Board of County Commissioners requested a more detailed review of the financial impact of this tax break and asked Mr. Whitacre to work with the Garrett County Department of Financial Services to obtain more information.

2. Mr. Null reviewed a number of administrative, non-privileged personnel, and managerial matters under his authority and jurisdiction with the Board of County Commissioners.

## **PUBLIC SESSION**

- Mr. Null indicated there was no addition or deletion to the Public Meeting Agenda. The Board of County Commissioners, on a motion by Commissioner Hinebaugh, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved the Public Meeting Agenda for October 19, 2021.

- 3. **Update on County Response to COVID-19:** Robert Stephens, Garrett County Health Officer provided an update on COVID-19 and vaccines.

# **Update on COVID cases**

- Garrett County is currently number one in the state with a 13.44% Positivity Rate and 45.99 Case Rate with five new deaths reported last week, for a total of 76 deaths.
- Employees with the hospital, medical practices, the health department, schools, and healthcare providers, are very tired. Restaurants are still closed as of this date due to outbreaks. The solution is being vaccinated. It is very important that people get the vaccine.

#### Vaccine Boosters.

- There are a lot of people interested in the booster. Currently only those who need the third dose because they are immunocompromised are eligible.
- The only vaccine approved for a booster dose is Pfizer. That is an issue because much of the early
  distribution of vaccines by the Garrett County Health Department was Moderna, which cannot be
  used for boosters.
- If and when Moderna boosters are approved they will be available in half-doses and most likely recommended only for those over the age of 65, residents of long-term care facilities, people over the age of 18 with medical conditions like asthma and diabetes, and those who work in high-risk infection settings such as education, medical care, transportation, or law enforcement.
- Question Can vaccines be mixed? Research is showing that mixing vaccines may be just as effective but check with your health care provider.

# Opioid Epidemic

• Garrett County is one of the few counties in Maryland where overdose deaths have been reduced; however, we are beginning to see an increase in Fentanyl overdoses. Remember treatment works.
