The Fiscal Year 2024 audited fund balance assignments and carryovers were reviewed and approved to amend the Fiscal Year 2025 Budget.

Question – What changed in the budget that enabled the Board of County Commissioners to provide a property tax rate cut? Based on the County's forecast model it was anticipated that property assessments would remain stable or decline slightly; instead, there was a slight increase. The County also anticipated income tax revenues to return to near pre-COVID levels, yet we continue to see an uptick in income tax receipts.
