The Board of County Commissioners, on a motion by Commissioner Savage, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved the sale of Real Property, located at 102 North Eighth Street, Oakland, Maryland, consisting of 1.296 acres, for the sum of One Dollar (\$1.00), to the Town of Oakland, Maryland and authorized Chairman Edwards and Mr. Null, on behalf of the Board of County Commissioners, to execute all documents relative to this transfer of property to include Resolution 2025 - 8 and Deed to be recorded.

The property, formerly owned by the Garrett County Board of Education and used as a warehouse facility, was recently relinquished back to the County. The County conveys this property to the Town of Oakland.
