• The Kitzmiller Community Center Energy Efficiencies
The Kitzmiller Community Center is the hub of the community.
The Center houses a Senior Center/Meals on Wheels, a branch of the Ruth Enlow Library, Head Start and Youth Sports
Leagues.

The project is to replace 53 windows and a double door with new energy efficient windows and doors. The windows and doors are original to the building that was built in 1926. Estimated cost-\$98,100.

• Garrett County Health Department Energy Upgrade
Replace the existing boiler heating system with energy efficient
heat pump chillers. The upgrade will help us to meet the
requirements of the Climate Solutions Act for this building.
Estimated cost-\$230,700.
