1. The Board of County Commissioners, on a motion by Commissioner Savage, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved the Public Meeting Agenda for February 2, 2026.
2. The Board of County Commissioners, on a motion by Commissioner Tichnell, which was seconded by Commissioner Savage, and made unanimous by Chairman Edwards, approved the Public Meeting Minutes of January 5, 2026.

3. Angie Pase, Development Director, Tucker Community Foundation, presented a briefing on the annual "Run For It" 2K walk and 5K run event. The event provides nonprofits with an opportunity to increase awareness and support for their respective organizations.

In 2025, five (5) teams with 126 racers from Garrett County participated in this event. The Board of Garrett County Commissioners contributed \$2,000.00 which generated \$91,401 for nonprofit, civic, and charitable organizations in Garrett County.

Since 2014 Garrett County's total investment of \$19,000.00 has returned \$377,947.00 in grant funding to County non-profits including \$18,500 in scholarships. Ms. Pase asked the Board of County Commissioners to consider contributing \$2,000 again in Fiscal Year 2027 for this worthy cause.

4. **RESOLUTION 2026 - 1:** Sale of 3.03 acres in the McHenry Business Park to Prime Vacation Rentals, LLC for the sum of Twenty Thousand Dollars (\$20,000.00) per acre.

The Board of County Commissioners, on a motion by Commissioner Savage, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved Resolution 2026 – 1.

5. **Maryland Prescription Drug Plan** - Vincent DeMarco, President, Health Care For All and Dr. Andrew York, Executive Director, Prescription Drug Affordability Board, presented the Board of County Commissioners with an overview and goals of the Maryland Prescription Drug Plan and how this could benefit the citizens of Garrett County by helping manage medical costs.
