Steve has secured new locations for three precincts as well as one Early Voting Center. The changes are as follows:


- Precinct 6, Sang Run, will be relocated to the Ag Heritage Hall at the Garrett County Fairgrounds.

- Precinct 3-2, Jennings, will be relocated to the Grantsville Fire Department in the new reception hall.
- Early Voting Center 2, which was previously located at the Northern Outreach Center on Hilltop, just East of Grantsville, will now be relocated to the Grantsville Fire Department in the new reception hall. The outside Ballot Box in the Northern end of the county will also be moved to the Grantsville Fire Hall.
