APPROVAL OF MINUTES:

The minutes for the March 29th, 2022 meeting was approved on a motion made by Chuck Nolan, seconded by Jim Moore and made unanimous by Randy Glotfelty.

ELECTION DIRECTOR REPORT:

There were 74 new registrations and 35 removals in April. Active registered voters are as follows for Garrett County: Democrat – 3,764, Republican – 13,518, Green Party – 26, Libertarian – 97, Working Class – 19, Unaffiliated – 2,811, and other parties – 165, for a total of 20,400.

On June 30th Steve will be meeting, via Google Meets, with Maryland Emergency Management and the National Weather Service ahead of the Gubernatorial Primary Election with an update on July 14th.

ES&S picked up the Ballot Marking Device stand cases which freed up much needed warehouse space.

Garrett County has received 1,246 Mail-In Ballots to date.
