ELECTION DIRECTOR REPORT:

There were 207 new voter registrations and 166 removals in July and August combined. Of the removals 72 was due to the confirmation mail process and 36 were voters who are now deceased.

On August 17th, Steve attended a virtual directors meeting. This was officially the last meeting that Nikki Charlson (Deputy), Donna Duncan (Administrator Assistant) and Shelly Holland (Finance Director) will be attending as they are leaving the State Board of Elections. Katie Berry was named as the new Deputy Director to replace Nikki Charlson. Shafiq Satterfield is leaving State Board of Elections and going to Prince Georges Board of Elections in the IT department.

It was announced at the August Directors Meeting that the new pollbooks will probably not be utilized for the 2024 Elections, The State has not received the entire allotment and the software is not compliant yet.

Quarterly charging has been completed on the DS200's (scanners) and the ballot marking devices.

Steve has been in contact with both early vote centers. Oakland Community Center has been reserved and Steve has a meeting on September 7th, at the Grantsville Fire Hall to discuss the vote center there.
