### APPROVAL OF MINUTES:

The minutes for the May 7<sup>th</sup>, 2024 meeting was approved on a motion made by Chuck Nolan, seconded by Randy Glotfelty, and made unanimous by Connie Meyers.

### ELECTION DIRECTOR REPORT:

Voter Registration was closed due to the Primary Election until May 27<sup>th</sup>. From that date until the end of May, there were 14 new voter registrations and no removals.

For the Primary Election in Garrett County, 5,912 voted which is 34.41%.

- 1,114 or 19% voted at an Early Voting Center
- 3,338 or 57% voted on Election Day at their precinct
- 1,404 or 24% cast a Mail-in-Ballot
- 56 or .01% voted by Provisional Ballot

All Election Results and Audits for the Primary 2024 Election has been submitted to the State Board of Elections.

When the State Board of Elections releases the voting equipment we will begin removing all ballots and start the counting process. The post election maintenance on the equipment will then be performed.

On June 3<sup>rd</sup>, Steve mailed a thank you note and schedule for the General Election to all polling places.

On June 18<sup>th</sup>, Steve will have a virtual Election Judge Lessons Learned with the State Board of Elections.

On June 19<sup>th</sup>, the office will be closed in observance of Juneteenth.

On June 20<sup>th</sup>, Steve will virtually attend a Directors Lessons Learned training with the State Board of Elections.

There is a tentative date of September 21<sup>st</sup>, for the Election Judge Refresher Training. It will be at the Performing Arts Center at Garrett College and will be held at 9:00 a.m.
