

## MINUTES

The Garrett County Board of License Commissioners / Liquor Control Board held their monthly meeting on Thursday, June 13, 2019 at 9:00 AM in the Commissioner's Public Meeting Room 209. Present for the meeting was Chairperson Michael Fratz, Commissioner Lisa Herman and Administrator to the Board Deborah Owston.

Chairperson Fratz called the meeting to order. The Board signed mileage sheets.

The Board approved the May 7, 2019 minutes. Chairperson Fratz made the motion. The motion was seconded by Commissioner Herman and unanimously approved.

There was general discussion before the hearings. The 2019 legislative bills for Garrett County HB 723 / SB 547 go into effect on July 1, 2019 – Chapter 689. The 2019 alcoholic beverage license approval and late application were discussed. The Board approved the renewal applications that were submitted. Wilhelm Recreation conducted a Cash Bash fundraiser on May 18, 2019. The Celtic Festival was held on June 1, 2019. The Friendsville VFRD and Maryland Meadworks LLC provided the alcohol. A discussion took place about the late notification and lack of organization. The Board decided that next year the event organizer must meet with the Board. The Chamber of Commerce BAH will be held on June 13, 2019 at Garrett College. The Pawn Run Saloon license was transferred on June 1, 2019. Roger Resh of Grantsville Liquors passed away on May 12, 2019. A Certificate of Permission was issued to Carol Lawson on May 20, 2019. Don Patron restaurant is working on submitting an application for the July LCB meeting. The local resident will be Jessica Salinas. Sandy Fazenbaker is working on submitting a transfer application for the license at Hilltop Restaurant for the July meeting. Craig Phillips of CGP MD Foods, LLC is purchasing Browning's Shop N Save in Oakland. Pat and Michelle Hudnall are working on submitting an application for the Vagabond Taproom on Alder Street. Cindy's Place will probably transfer at the end of the year. John's Corner requested approval for the Delivery Option and Draft Beer effective July 1, 2019. The Board approved the request. The license upgrades will go into effect once the issuing and annual fees are satisfied. Compliance checks were conducted on May 18, 2019, June 3, 2019 and June 10, 2019. There were 31 checks attempted with one violation. Hav-A-Lot store in Bloomington appears to have closed on June 1, 2019.

A license hearing was held at 9:20 AM for a Special Class "C" Per Diem 2-day BWL License for the Grantsville Lions Club. The license will be used on June 29, 2019 at the Grantsville Town Park during the Grantsville Days celebration. Applicants for the license are Jeremy Layman and Duane Stein II. Mr. Layman was present for the hearing. The beer trailer will be set up in the lawn between the ball field and stage. Ms. Owston read the responses from the questions on the Special Class C "Notification of Event" form that was submitted with the application. Chairperson Fratz made a motion to approve the Special Class "C" Per Diem License for use on June 29, 2019 at the Grantville Town Park. The motion was seconded by Commissioner Herman and approved. After the appropriate fees were paid, the license will be issued.

A license hearing was held at 9:40 AM for a Special Class "C" Per Diem 2-day BWL License for Garrett Trails, Inc. The license will be used on June 22, 2019 outside in the parking lot

areas of Garrett College. Applicants for the license are Steve Green and Mike Logsdon. Ms. Ashlee Boyd, of Garrett Trails was present for the hearing. The beer trailer will be set up outside in the parking lot as noted on the map provided in the application. Ms. Owston read the responses from the questions on the Special Class C “Notification of Event” form that was submitted with the application. Chairperson Fratz made a motion to approve the Special Class “C” Per Diem License for use on June 22, 2019 at the Garrett College. The motion was seconded by Commissioner Herman and approved. After the appropriate fees were paid, the license was issued. .

The next regular meeting of the Board of License Commissioners is scheduled for Thursday, July 11, 2019.

There being no further business to discuss, Chairperson Fratz made a motion to adjourn the meeting. The motion was seconded by Commissioner Herman and approved.
