

## MINUTES

The Garrett County Board of License Commissioners / Liquor Control Board held their monthly meeting on Thursday, March 10, 2022. The meeting was conducted at 9:00 AM in the Commissioner's Public Meeting Room 209. Present for the meeting was Chairperson David Moe, Commissioner Lisa Herman, Commissioner Michael Fratz, Administrator to the Board Deborah Owston and Attorney to the Board M. Elizabeth Georg.

Commissioner Moe chaired the meeting and called the meeting to order. The Board signed mileage sheets.

The Board approved the February 10, 2022 Minutes. Commissioner Herman made the motion to approve the Minutes as amended. The motion was seconded by Commissioner Fratz and made unanimous by Chairperson Moe.

There was general discussion before the hearings. Ms. Owston updated the Board on the current legislation. SB415/HB1118 Garrett County Alcoholic Beverages Act of 2022 is moving through the House and Senate without any concerns. SB0603/HB0506 Constitutional Amendment – Beer and Wine Licenses Retail Grocery Establishments. HB1406 Issuances of Class A Licenses. Graze LLC dba Pawn Run update. S&S Store license update. May need to extend the Board's approval. Friendsville VFRD gun bash on February 26, 2022. Eastern Garrett VFRD gun bash on March 5, 2022. Oakland VFD gun bash on March 12, 2022. Friendsville Public House incident on February 26, 2022. Bartender services for catered and private events.

A hearing was held at 9:20 AM for a new Class B BWL On-Sale 7-Day License in accordance with the Alcoholic Beverages Article § 21-902. Applicants for the license are Jason Cayer and Drew Algeo. Both applicants were present for the hearing. The applicants have equal ownership in the business. The legal entity name is Deep Creek Bar and Grill, LLC. The trade name will be Deep Creek Bar and Grill. The restaurant is located at 17869 Garrett Highway, Suite A, Oakland, Maryland. Ms. Owston reviewed the license issuance procedures and regulations. Commissioner Herman made a motion to approve the Class B BWL On-Sale 7-Day License. The motion was second by Commissioner Fratz and unanimously approved by Chairperson Moe. The license will be issued upon payment. The owners expect to open the beginning of April.

A hearing was held at 9:40 AM for a new Class B Beer & Wine On-Sale 7-Day License in accordance with the Alcoholic Beverages Article § 21-803. The applicant for the license is Catherine S. Newhall. Ms. Newhall is the sole applicant and applying as a sole proprietorship. The trade name is Swallow Falls Country Store. The business is located at 2500 Swallow Falls Road, Oakland, Maryland. Ms. Newhall along with Jody Friend were present for the hearing. Ms. Owston noted there were still some outstanding administrative items. A brief discussion took place about the license privileges and the business. It was determined that it would better to issue a Class D Beer & Wine 7-Day license in accordance with the Alcoholic Beverages Article 21-806. Ms. Owston reviewed the license issuance procedures and regulations. Commissioner Herman made a motion to approve the Class D Beer & Wine 7-Day License pending the outstanding administrative items. The motion was

second by Commissioner Fratz and unanimously approved by Chairperson Moe. The license will be issued upon receiving the outstanding administrative items and payment.

The next regular meeting of the Board of License Commissioners is scheduled for Thursday April 14, 2022.

There being no further business to discuss, Commissioner Herman made a motion to adjourn. The motion was unanimously approved.
